Natural Resources Wales (NRW) is the largest Welsh Government public sponsored body with just under 2000 staff, an operating budget of £17 million and manages 7% of the land in Wales. Our purpose is to ensure that the environment and natural resources of Wales are sustainably maintained, enhanced and used, now and in the future.

NRW feels that the seven outcomes listed are relevant and appropriate, but notes that some are far more difficult to measure than others e.g. levels of happiness and resilience.

The list could also be expanded to make other outcomes explicit rather than implicit.

Question 3 – If the outcomes are not representative, what is missing?

To reflect one of the key themes of the Foundation Phase, all children in the early years:

Should have an awareness and appreciation of their natural environment Should have access to outdoor spaces and quality natural environments Should have regular access to hands on learning and play experiences in these environments

Experiences in the natural environment can contribute to 5 out of the 7 listed outcomes:

- 1. "are and feel safe" children require regular access to the natural environment in order to feel comfortable and safe in an environment they may not experience as part of family life
- 2. "are resilient, capable and coping" learning experiences in the natural environment can allow for managed risk taking contributing to children becoming resilient, capable and able to cope
- 3. "are healthy" the physical and mental health benefits of time spent in the outdoors are well documented and the increased opportunities for physical activity in the outdoors at a young age can contribute to a future healthy adult lifestyle
- 4. "learn and develop" The benefits of learning and developing in the outdoors are well documented (ref Module 6 of the Foundation Phase

Training Pack and document number 0022/2007 – Out of Classroom Learning)

5. "are happy" - Although harder to measure, learning and playing in the natural environment is beneficial for those children who are not as comfortable in a formal classroom setting and these experiences could contribute to increased levels of happiness.

From NRW's point of view, we feel it is essential for all children and young people to grow up valuing and feeling connected to the natural environment, in order to understand its importance to society. If this is embedded at an early age, the later acquisition of skills and the application of these through employment opportunities will contribute to the essential sustainable use and management of Wales' natural resources in the future.

NRW can see how our contribution to the early years in Wales fits into the Framework but are concerned that the role of the natural environment or learning outside the classroom is not mentioned at any point in the document. It also wasn't mentioned in the "10-year plan for the early years, childcare and play workforce in Wales". However with the Environment Bill, Wellbeing of Future Generations Bill and the formation of Natural Resources Wales as a major component in the solution to the sustainable management of our natural resources now and in the future, NRW feels it is essential to make the importance of the natural environment and its natural resources explicit in all government documents. The children that this Framework will affect will be the future generation with responsibility for the sustainable management of Wales' natural resources and it is imperative that ESDGC messages are woven into early years practice from the start – access and experience of the natural environment through learning and play is the easiest way to ensure this.

NRW manages a variety of sites across Wales, woodlands, nature reserves and also helps manage in partnership many other green spaces. Many of these sites are easily accessible and include trails, play areas and education activities.

NRW's Education, Learning and Sector Skills team also offers supported visits and training for practitioners wishing to self-lead or develop activity ideas for play and learning in the natural environment.

Through the Wales Woodlands for Learning Team, NRW has supported the writing of Module 6 and the subsequent training of Foundation Phase Practitioners and continues to train Foundation Phase staff, child minders, play workers and has links to Flying Start and Healthy Schools staff and provides a facilitated network through Outdoor Learning Wales where any practitioner can join the local group, gain support and take advantage of opportunities for CPD.

NRW would be happy to discuss ways to work with the Early Years Department in the future to jointly help support the Framework and NRW's outcomes.
