

# **Proposed changes to Liverpool Bay / Bae Lerpwl Special Protection Area:**

# A consultation

# Introduction

The purpose of Natural Resources Wales (NRW) is to ensure that the environment and natural resources of Wales are sustainably maintained, used and enhanced, now and in the future.

One of NRW's roles is to advise the Welsh Government on the identification of Special Areas of Conservation (SACs) and Special Protection Areas (SPAs). SACs and SPAs, also known as 'Natura 2000 sites' or 'European sites' are measures required under EU law for the conservation of biodiversity. SPAs are designated to protect populations of rare, threatened or migratory species of wild birds and the habitats they depend on, while SACs are designated to protect a range of natural habitats types and species of plants and animals other than birds.

Decisions on whether to designate SACs and SPAs in Wales and Welsh inshore waters within the 12 nautical mile Territorial Sea limit are made by the Welsh Ministers. Decisions on whether to designate SACs and SPAs in English inshore waters and in offshore waters beyond the 12 mile limit are made by the UK Secretary of State.

Liverpool Bay / Bae Lerpwl SPA, which lies in both English and Welsh waters, was designated in 2010 in recognition of its internationally important non-breeding populations of common scoter *Melanitta nigra* and red-throated diver *Gavia stellata* and a non-breeding waterbird assemblage.

In April 2016, Natural England (NE), NRW and the UK Joint Nature Conservation Committee (JNCC) submitted to the UK and Welsh Governments proposals to:

- extend the Liverpool Bay / Bae Lerpwl SPA to include additional marine areas;
- add further species to the list of individual bird species for which the SPA is designated, namely:
  - o breeding population of little tern Sternula albifrons
  - o breeding population of common tern Sterna hirundo
  - o non-breeding population of little gull Hydrocoloeus minutus;
- recognise further named species within the non-breeding waterbird assemblage, namely little gull *Hydrocoloeus minutus*, red breasted merganser *Mergus serrator* and great cormorant *Phalacrocorax carbo*.

The location of the SPA and the proposed extensions are shown in a series of maps available on the <u>Natural England</u> website. The proposed extensions to the SPA boundary include a small inter-tidal area in Wales and a larger extension mainly in English waters but which also extends into UK offshore waters beyond the 12 mile limit.

Welsh and UK Ministers have asked NE, NRW and JNCC to carry out a public consultation on the above proposals. Information on how to respond to the consultation is given below.

## What is the purpose of this consultation?

Consultation over proposals to designate SPAs in inshore waters is a statutory requirement under Regulation 12B of the Conservation of Habitats & Species Regulations 2010. Consultation over proposed SPAs is required by Regulations 8 and 13 of the Offshore Marine Conservation (Natural Habitats, &c.) Regulations 2007.

After the end of the consultation period, NE, NRW and JNCC will be reporting to Welsh and UK Government on the representations we have received.

There are two parts to the consultation:

# 1. Consultation on the proposed changes to the Liverpool Bay / Bae Lerpwl SPA (NE, NRW and JNCC)

We are seeking the views of stakeholders on the **scientific basis** of the proposed changes to the SPA. We are particularly interested in comments on the way in which data on the relevant bird species have been used to develop the proposed changes to the SPA boundary and to evaluate the site against the relevant guidelines for the identification of SPAs.

# 2. Consultation on a draft assessment of the potential social and economic impact of the proposals in Wales (NRW only<sup>1</sup>)

NRW has drafted an assessment of the potential social and economic impact of the proposed changes to the Liverpool Bay / Bae Lerwpl SPA, insofar as they relate to Welsh inshore waters. We are consulting on this draft to assist with identifying any additional information or evidence that would help improve the assessment.

In preparing our reports to the Welsh Government and UK Government, NE, NRW and JNCC will take into consideration all representations received. However please note that subsequent decisions by UK and Welsh Ministers on whether to designate the changes to the SPA may only take into account relevant scientific information and must be based on application of relevant guidelines and criteria. Social or economic considerations will be reported on, and can inform decisions about the way in which SPAs are managed and regulated, but may not be taken into account by Ministers in decisions on whether to designate SPAs or in the determination of their boundaries.

The <u>Draft Impact Assessment</u> assesses the potential impacts associated with the pSPA proposals regarding their interaction with human activities in and around the sites.
