Identity and contact details of the Data Controller

Natural Resources Wales (NRW) is the Data Controller and is committed to protecting the rights of individuals in line with the Data Protection Act 2018 (DPA) and the UK General Data Protection Regulation (UK GDPR).

What information do we collect about you?

Name, address and contact details; telephone numbers; email addresses and, where appropriate, photographs.

How will your information be used?

- Responding to enquiries/complaints
- For inclusion in your Community Flood Plan
- To contact you about flood risk in your area
- To invite you to meetings and events about flooding
- To capture information about where we have carried out engagement activities
- To keep a log of when materials or publications are shared with you
- Photographs used on materials to promote the Community Flood Plan locally
- Photographs of events for use in internal reports and to promote the events on social media

What is our legal basis for processing your personal data?

Data Subjects will provide Consent for NRW to process their personal data. They have the right to withdraw consent at any time by contacting the Data Protection Officer on the above contact details.

Who receives your information?

Where we are responding to enquiries we may need to share your data with other Risk Management Authorities in order to respond to you accurately. This could include Emergency Services; Local Authorities; Water Companies and other service providers.

Only Community Flood Plans may be shared with our Responder Partners via Resilience Direct; a secure, multi-agency platform. This enables your plan to become part of everyone's emergency response procedure. (Currently in North Wales).

If you have consented to receive Flood Warning alerts, your information will be shared with the Flood Warnind system. Further information on how your data will be processed by this system can be found here Natural Resources Wales/Sign up to receive flood warnings

How long will your information be held?

We will hold your data and use it until you inform us that you no longer want to receive information from NRW.

What are the individual rights?

You have the right to to access your personal information, to object to the processing of your personal information, to rectify, to erase, to restrict and to port your personal information. Please visit our Data Protection webpages for further information in relation to your rights
